By providing your personal information you agree and consent to the collection, use, disclosure, storage and holding of your personal information in accordance with this privacy policy.

## Privacy Compliance

This privacy policy statement has been made in accordance with amendments to the Federal Government Privacy Amendment (Private Sector) Act 2000 (New Privacy Laws) which took effect from 21 December 2001 as well as the Spam Act 2003 which took effect from 10 April 2004. TECHmosis collects information from users, which may include personal information, at different points on our website as follows: When you visit our website, our server makes a record of your visit and logs the following information for statistical purposes:

- The pages you accessed and the documents downloaded
- The date and time of your visit to the site
- The type of browser you are using

We receive and store information you enter on our website or give us in any other way. We ask that you provide basic contact information such as your name, phone number, address, and email address so that we can process it. We may also collect additional information at other times, including but not limited to, when you provide feedback, supply information about your business network infrastructure or other details that allow us to provide our service to you or allow you to communicate with TECHmosis customer support. TECHmosis does not currently issue any marketing newsletters however we may use personal information collected from you, sometime in the future for the purpose of providing you with direct marketing material and information in the form of a newsletter. This will only apply if you have registered or subscribed to such publications by your registering your details with us. However if you wish to cease receiving any such information you may let us know either by email or mail and your request will be completed within five working days. Individual and company details are not used for any other purpose. Details are only supplied to a third party supplier when it is required by law, for goods or services which you have purchased.
